

**MAJOR LEAGUE FISHING: PRO CATCH SWEEPSTAKES PROMOTION**  
**(the “Promotion”)**

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PAYMENT OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. All other individuals are not eligible to participate in the Promotion or win a Prize.

This Promotion is open only to any legal resident of the 50 United States or the District of Columbia who is at least thirteen (13) years of age or the age of majority in their place of residence, whichever is greater, as of the commencement of the Promotion Period (defined below).
